Applications are invited from the Indian Citizens above 18 years of age with a minimum educational qualification of Madhyamik for enlistment as Para Legal Volunteers (PLVs) against honorarium only for their deployment in various Village Legal Care & Support Centres (Legal Aid Clinics).

The enlistment of the PLVs will be on purely temporary basis for one year and this is in no way connected with any sort of Government employment.

There shall be no bar as to any caste, creed, sex and religion for such enlistment. The applicant is required to submit their applications in plain paper as per proforma by affixing one passport sized color photograph stating the area in which he/she is willing to work, but they may be deployed elsewhere, if required.

The applicant is also required to express their willingness to work voluntarily against honorarium with an undertaking, that they have understood the fact fully, that the work of PLV is not a Government employment.

The existing PLVs are also required to submit their applications afresh.

It is further notified, that any such PLV, even after selection, may be removed and discontinued at any time purely at the sole discretion of the Learned Chairman, DLSA, Malda.

The application must be submitted in a sealed cover in the Office of the DLSA, Malda (District Court Compound).

The last date for submission of application is **18-09-2015**.

Service in case of the applicant is a retired person.
- 2) One recent passport size photograph self attested is pasted at the proper place of applicant proforma.
- 3) All the original documents must be produced at the time of interview for verification otherwise the applicant will not allowed to appear for the interview.
- 4) One self addressed envelope to be enclosed with postal stamp of Rs. 05.00.
