**NOTICE**

Applications are invited for 6 PLVs from the Local residents of Bhutni & Gadaichar, villages, and 6 PLVs from other villages of the Malda District, having minimum educational qualification of Madhyamik passed for enlistment as Para Legal Volunteers (PLVs).

The minimum age of the applicant shall not be less than 18 years as on the date of application. There is no bar against the maximum age. A retired government employee may also apply.

The enlistment of the PLVs before the District Legal Services Authority will be purely on temporary basis for the period of one year and this is in no way connected with any sort of Government employment.

The work of PLVs does not carry any salary, remuneration or wages except Honorarium fixed by the DLSA, Malda from time to time.

There shall be no bar as to any caste, creed, sex and religion for such enlistment. Preference shall be given to the women candidates.

The applicant is required to submit their applications in plain paper as per proforma by affixing self attested passport sized color photograph stating the area in which he/she is willing to work, but they may be deployed elsewhere, if required.

The applicant is also required to express their willingness to work voluntarily against honorarium with an undertaking, that they have understood the fact fully, that the work of PLV is not a Government employment.

It is further notified, that any such PLV, even after selection, may be removed and discontinued at any time purely at the sole discretion of the Chairman, DLSA, Malda.

The application must be submitted in a sealed cover in the Office of the DLSA, Malda (District Court Compound).

The last date for submission of application is **23-08-2017**.

- 1) Self attested copies of all documents be attached in respect of educational qualification, experience, residential proof, age proof (Birth certificate or Madhyamik Admit card), Voter Card/ Ration Card/Passport, proof of retirement from Govt. Service in case of the applicant is a retired person.
- 2) One recent self-attested passport size colour photograph to be pasted on application form.
- 3) All the original documents must be produced at the time of interview for verification otherwise the applicant will not be allowed to appear for the interview.
- 4) One self addressed envelope to be enclosed with postal stamp of Rs. 05.00.
